MEMBERSHIP APPLICATION

There are two types of membership, **Ordinary Membership** and **Associate Membership**.

ORDINARY MEMBERS

Any company registered and authorized to carry out business in Malaysia. A company's Membership Category is based on its Issued Capital or No. of Employees. Should a company qualify for more than one membership category, the membership category with a higher annual subscription will apply.

ASSOCIATE MEMBERS

Any association, non-profit organisation, public university, or company registered outside of Malaysia. An Associate Member shall have the like rights and duties of an Ordinary Member save that it shall not be entitled to vote at General Meetings of the Chamber nor be appointed or elected as a member of the General Committee.

SUBSCRIPTION PAYMENTS

The annual subscription fees shall be due and payable in advance on the first day of January each year. A Member newly elected during the year shall pay subscription fees for the unexpired portion of such year, calculated from the first day of the month following the month in which the Member is elected. The MICCI Membership follows the calendar year commencing 1 Jan and expiring 31 Dec.

Ordinary C	Companies with issued capital from RM100,001 to RM250,000 or with 11 – 50 employees	RM1,960.00
Ordinary D	Companies with issued capital up to RM100,000 or up to 10 employees	RM1,350.00
Associate	Any Association, Non-Profit Organisation, Public University, or Company Registered outside of Malaysia	RM1,300.00
Entrance Fee: RM500.00 (for the first year only and inclusive of 0% GST)
